**Dog Ordinance.** Fountain Green City has an **Animal Control Ordinance. 13-20-3-02. License And Registration Required.** **All** dogs need to be licensed each year. **Dog Licenses are due by June 1, 2025. There will now be a \$30.00 late charge assessed. 13-20-3-04. Running At Large Prohibited.** It shall be unlawful for the owner/keeper of any dog to permit such dog to run at large (All dogs should be on a leash unless otherwise contained on the owner's property). **13-20-3-08. Dogs Required to Have Rabies Shots.** All dogs within the city shall have **proof** of up-

to-date rabies shots. If you have dog complaints, please call Fountain Green City Animal Control Officer– Amy at **435-469-0018**.

**Fountain Green City Land Use Ordinances.** The Citizen’s Guides to the Bldg. Permit Process have both been updated and revised. For structures **less than 200 sq.ft. without utilities**, a permit, and setback verification is required by appointment (through the city office). There is a small fee, but no application to the Planning Commission is required. For structures **greater than or equal to 200 sq.ft. with or without utilities and structures less than 200 sq.ft. with utilities**, setback verification, and application to the Planning Commission are required. Applications are available at the City Hall. All paperwork must be submitted at least one week before the meeting of the Planning Commission. Setback requirements have been relaxed and exact requirements can be found on the Fountain Green City website or at the City Hall. If you have any questions, you may be referred to the secretary or chair of the planning commission.
